- 2. The position of Assistant Principal shall be abolished and the administrator currently possessing bumping rights who is tenured shall be placed on a preferred eligibility list in accordance with tenure and seniority rights.
- 3. The position of Supervisor of Instruction, Achievement and Student Activities shall be abolished and the administrator currently employed in that position, who is non-tenured, shall be issued a notice of non-renewal for the 2019-2020 school year.
- 4. The position of Supervisor of Special Services shall be abolished and the administrator currently employed in that position who is tenured shall be placed on a preferred eligibility list in accordance with tenure and seniority rights.
